

MINUTES

SENIOR BOARD MEETING No. 36, 14 and 15 November 2018

The five members of the Senior Board held their thirty sixth formal meeting on the 14th and 15th November 2018. The event took place at the CFP headquarters, Praça de Alvalade, n.º 6 – 10.º, in Lisbon, and started at 16h00m. All members attended: Teodora Cardoso, who chaired, Paul De Grauwe, Miguel St. Aubyn, George Kopits and Carlos Marinheiro. Luis Centeno, head of staff, was also present.

1. Decisions

2. Preparation of the parliamentary hearing on the Draft State Budget for 2019

The draft presentation intended to be used in the parliamentary audition has been handed to the members of the Board and discussed in detail. The Board agreed with the content of the draft.

The Board decided to adjourn the meeting to the following day.

The meeting reconvened on the 15th November, after the hearing on the Parliament.

3. Discussion on the CFP external review of by the OECD

The Board briefly discussed the external review by the OECD. The presentation of the report at the OECD annual conference of PBO/IFI was considered an important landmark for CFP.

4. State of play in the hosting of the OECD IFI/PBO annual meeting in Lisbon on the 4th and 5th of February 2019

The Board was briefed in the developments of the process.

A formal acceptance of the dates proposed (February 4 and 5 of 2019) is a milestone to be reached in the next few days.

Furthermore, the Senior Board was informed about a meeting scheduled for the following day, with Robert Chote, president of the PBO/IFI group, Scherie Nicol from the OECD, and Nuno Baleiras from UTAO to start discussions about the themes to be addressed at the meeting.

5. Discussion on the position to adopt regarding the difficulties in access to Social Security information

The Senior Board was provided with a brief presentation of the past steps in this process, that included a large number of written communications and phone calls, a public statement according to article 8th number 1 of the Statutes and a formal letter written to the Minister of Social Security that has been replied by the Chief of Staff of the Secretary of State for Social Security with a partial satisfaction of our requests, on paper support, and the promise that they will study the best way to provide us with information.

Several further steps were considered with a number of possible solutions. Finally, the Board decided to continue insisting with the Ministry.

6. Future organisation and funding of the EUIFI Network Secretariat

The Board discussed the options on the table and decided that the solution to be adopted should be that the IFI with the presidency should choose and support the secretariat. The Board also decided to assume that it will be ready to assume the presidency and the secretariat at a future date.

7. Next Senior Board Meeting schedule

The next meeting was scheduled for early February 2019.
